70/07 **POLICE LIAISON**

Wisbech and District Neighbourhood Safer Neighbourhood Panel Meeting held at Parson Drove Village Hall on 10th July 2007 – the priority for rural villages was once again speeding.

71/07 JOHN DUBBER PARISH COUNCIL LIAISON OFFICER

Results from the Parish Plan should feed into the Community Strategic Plan next year.

Some of the proceeds from the Housing Stock transfer are beginning to be allocated:- £50,000 for the Gorefield Sports and Amenity Centre, £50,000 for mobile village exercise centre, £10,000 for sports equipment for local clubs, £100,000 for other Village Halls. Youth Council Gants are available, £85,000 for streetlight survey in villages.

Golden Age Fair held at Leverington was very well attended. A Golden Age web site has now been set up.

Nene Water Front all sites now secured. Boat House now being built.

Fenland DC now going through inspection results due in December.

Mr Dubber suggested that if the Parish Council has issues about Highway matters they invite their Cambridgeshire County Councillor to attend a meeting with a senior officer from Highways.

Councillor Mrs Hall has been given a map of a route for a new relief road for Wisbech.
