80/10 POLICE LIAISON

Crimes reported since last meeting: theft of cycle, criminal damage to vehicle and a case of arson. Regular checks are been made at the Playing Field. PC Coales has visited Willow Lodge Residential home which is to be for 16 to 25 year olds with sever disabilities. Anybody is very welcome to visit. Speed watch is now up and running please let PC Coales know if there is any one interested in helping.

Councillor Holt asked PC Coales a few questions that were brought up through the Parish Plan. Neighbourhood Watch – where are they in the village – West End, Gote Lane, Fitton End and Black Lane. Crimes reported on Village Notice Board – PC Coales would have no objection to this as long as no names etc disclosed. Traffic congestion outside the School – Oxfield Drive is still not adopted yet so nothing can be done there at present.

81/10 NATALIE ROWLANDS NOMINATED OFFICER FOR FENLAND DC

Fenland Youth DC as £10,000 to give away to Youth Groups for projects, activities or equipment. The latest copy of the Fenland has recently been circulated giving details of all the summer holiday activities. Gate post has been concrete in and repairs to Multiplay and grass matting. Wren and the Lottery have both confirmed that they will give grants. Lottery to be used for toddler equipment and Wren for toddler swings and BMX track. Meeting next Thursday with Fenland Leisure to find out where track can be situated. Donarbon for adults exercise equipment has now progressed to stage two and information has to be submitted by 31st August 2010. Councillor Carroll would like to have a design painted on the concrete, possibly of the village so it could be used for remote controlled cars etc.
