### (2) Play Equipment

Unfortunately the Playfinder grant has still not been agreed. They were still not happy with the chosen pieces of equipment, the amount of natural play opportunities and the inclusion of the toddler swings. Councillor Carroll and the Chairman met with a representative of Fenland Leisure and have agreed some changes to the equipment to be provided. They are providing a plan which will also incorporate areas for natural play which will be finance by the Parish Council contribution to the scheme which will be approximately £1,900.

# (5) Replacement Pavilion

#### (6) Councillor Training

CPALC to deliver training locally, the cost being £350 based on 10 attendees. Councillor Development sessions are spread over 3 separate dates. Councillors who attend all 3 receive a certificate. #### (7) **Provision of Salt Bins**

Information received from Cambs CC with reference to the provision of salt bins. The salt bins will be provided on the basis that members of the public will spread the salt on a voluntary basis and that the County Council will not accept any liability for this activity. However they will refill the bins on request. The cost for the supply of the bin will be approximately £100. The positioning of the bin will need to be agreed with the Highways Supervisor. Agreed to go ahead and have a salt bin situated at Elloe Bank.

Pot holes – Gorefield Road and Highside

Councillor Carroll wishes to put a bus shelter up in his front garden, clerk to find out if he would need planning permission for this.

Planning enforcement to be informed about property in Cattle Dyke which is being used for business purposes.

Residents in Cattle Dyke are unhappy about how some properties are numbered, it is causing confusion for emergency services. Unfortunately there is nothing that can

be done about this other than giving specific instructions when asking for emergency services.

Access to Magnolia is causing some problems, this is a good argument for not allowing another property to be built there.

There was a burglary in the village over New Year. Councillor Mrs Hall will put a piece in the Village Voices. Resident of Cattle Dyke wanted people to know that their garden shed had been broken into.

Councillor Tierney reported on the A1101 improvement scheme which has been approved, road to be widened, straightened and double white lined.

Local residents are again concerned about speeding in the village. The only resource to combat this at the moment is to ask PC Coales to do speed checks. The Speed Watch scheme is up and running now but as Gorefield does not have any body taking part it cannot participate in the scheme.

The 'Emergency Vehicles Only' sign has been damaged outside Richmond Green. Roddons to be informed.
