Confirmation received from Heidi Wedge that even though developments are unauthorised the occupiers still pay Council Tax and get their bins emptied. She also confirmed that Council Tax is being paid by the occupiers of Thistledown and her investigations into this matter are on going.

72/15 MATTERS ARISING ON THE AGENDA

(1) **Highway Matters**

Black Lane still has had nothing done to it even though the Council was told that a scheme was in place. Clerk to find out what progress there is with this. Churchill Road is in a very poor state with the Tarmac lifting off from the concrete. Clerk to check to see if this road has been adopted by the Council. Cambs CC have confirmed that they will be replacing the signs at Wolf Lane junction with Leverington Common.

(2) **Play Equipment**

Latest inspection report makes the following comments:

Triple tower multiplay – security platforms loose due to wood drying out bolts won't tighten. Cableway – post loose in ground Swing step climber – support loose due to wood drying out bolts won't tighten Willow tunnel – needs cutting and re-weaving Roundabout – safety surface gap round surface Tea cup – play in bearing gap round safety surface Mototrek circuit – bolts loose won't tighten on rumble bridge and mini mound

Councillors Humphrey and Holt will look at these problems.

(3) **Co-Option of Parish Councillors**

Applications have been received from Mr David Humphrey and Mrs Pamela Reynolds. It was proposed by Councillor Mrs Hunns and seconded by Councillor Holt that they be accepted on to the Council. All were in favour. Letters to be sent inviting them to attend the next meeting.

(4) Vacant Garden Allotment (No 6)

This has been advertised to let but no one interested at the moment. Has been sprayed off but Mares Tail still there. Another spray will be used. Any costs incurred will be reimbursed.

(5) **Report from Allotment Inspection and Rent Review**

Cattle Dyke – all the allotments were in very good order Black Lane – there was some Black Grass present Churchill Road – all very well maintained except the vacant one

Rent review – it was agreed that all the rent are set at the appropriate level so no changes will be made.

(6) Review of Risk Assessment, Standing Orders and Clerks Salary

Updated the Parish Council Governance and Management Risk Register – copy attached.

Standing Orders need updating to cover the recording, broadcasting or transmitting the proceedings of a meeting. Clerk to search further for more information.

Clerk's salary – new national salary award for 2014 - 2016 has been released. At present the clerk is on SCP 21. Proposed Councillor Humphrey and seconded by Councillor Mrs Hunns that the clerk be rewarded for service and experience and moved up to SCP 23 £10.836 per hour. All agreed. Councillors wished it be noted that they are all very grateful for all the work carried out by the clerk.
