Streetlight damaged High Road/Cattle Dyke junction

Councillor Mrs Hunns gave report on meeting attended as Community Safety Champion. This will not only involve the police other parties will be getting involved. Meetings to be held monthly. Some speed cameras have been bought at a cost of £3,500. The idea of the meetings is to pass on problems from the Parishes. The next Neighbourhood Policing Meeting to be held at Parson Drove on 27th July. Information given out to Councillors about the launch of Smart Water Security System – a new forensic coding system. The cost of this is £40 but if order through Crime Reduction Unit it is £15 and for families with young children only £10.

Report of old trailer on the grass verge in Cattle Dyke. Arrangements to be made to get it moved.

Councillor Carroll gave a report from CPALC. Liaison meeting to be held with Fenland DC. Very short of members more Parish Councillors are needed to attend the meetings. Speaker from Wren to attend giving details of funding available. CPALC new web site up and running.
