50/14 **Public Participation**

56/14 MATTERS ARISING ON THE AGENDA

(1) **Highway Matters**

Overgrowing hedges continue to be a problem. Councillor Lay visited one of the properties but was not able to make any progress. Neil Band to be contacted again to be thanked for instigating the repairs to several pot hols recently but also asked to get the hedges cut back.

Local Highway Improvement Initiative 2015/16

As previously these schemes are jointly funded by Cambs County Council and the Parish Council. Application to be in by 12th September. The improvements to the footway along the High Road came under this scheme and hopefully this will be completed next year. Query as to whether this will have to come under the above scheme or not. If not then another project can be applied for. To be discussed further at the next meeting.

(2) **Bowls Club Lease**

A copy of a draft lease has been sent to the secretary, chairman and vice-chairman of the Bowls Club for consideration. Copy also circulated to all the Councillors. A meeting now to be arranged with all the chairmen and vice-chairmen to come some agreement on the lease.

(3) Play Equipment

Net ball post has been repaired with a painted board and a new net provided. On this weeks inspection sheet it says that the tyre on the zip wire needs replacing and the hand grips are still missing from a piece of the exercise equipment. The Landscape Group were asked to replace these a few months ago. To be reminded of this and asked for a quote for replacing the tyre.

(4) Review of Financial Regulations and Standing Orders

At the recent internal audit it was pointed out that the value which formal tender action is required was not uniform on both Financial Regulations and Standing Orders. It was agreed that item11section (f) should be changed to £25,000 in line with Standing Orders. The document was then reviewed and adopted by the Council. Proposed by Councillor Mrs Hunns and seconded by Councillor Humphrey.
