- Quotes have been received for the cutting of the playing field and the other areas in the village. Agriscape do not wish to quote for the work this year. T A Blackamore, who is already doing work at Leverington and Wisbech St Mary has quoted £44.72 per cut as apposed to £64.95 per cut by Groomfields. T A Blackamore has also quoted to do all the work undertaken by Agriscape for £30 per cut. Councillor Ridley proposed and Councillor Holt seconded the proposition that T A Blackamore be given the contract for all the playing field and village grass cutting. Everyone agreed.
