159/16 MATTERS ARISING ON THE AGENDA

(1) **Highway Matters**

Local Highway Improvement Initiative -2016/17 Gorefield has been successful with the project to extend the 30 mph speed limit along Wolf Lane with speed control measures.

Three property owners in the village have placed bollards etc outside their properties on the Highway verge. Clerk to write to them asking them to be removed.

(2) **Play Equipment**

Still have not received a quotation for repairs from the contractors and they are very slow sending in their weekly report. Weekly inspections are still being carried out. A net has been ordered for the basket ball post. Annual inspection will be carried out during April.

(3) Streetlights

Some Parish's have increased their Precept's considerably this year. Gorefield 's is only 1.7 %, whilst Doddington 65%, Manea 55%, Tydd St Giles 58% Wimblington 78% and Benwick 1.3%. These are to cover replacement street lights.

The price of a 41" high solar light bollard is £249.00. It was proposed by Councillor D Humphrey and seconded by Councillor Ms Reynolds that one be purchased as a sample and then if this is successful more will be purchased. Councillor Holt will visit Chapel Lane to decide on the most appropriate site.
