(1) **Highway Matters**

Order has been raised for the repair of the pot holes in Wolf Lane and one will also be raised for those in High Side

(2) Village Welcome Pack

John Timms to be asked how much he would charge to compile a pack similar to the one produced by a neighbouring village and then a local printer will be approached for his costs to print enough for every household in the village.

(3) Community Life Awards 2007

Chairman and Councillor Mrs Hunns will gather information together to make a submission.

(4) Youth Shelter

This will be discussed further after the Parish Plan results have been received.

(5) Playing Field Association

52/07 **PLANNING MATTERS**

Planning application received:

Application No F/YR07/0356/F – Erection of 14 dwellings 93 High Road and land east of Elm Haven West End – the Parish Council wishes to support the comments made by local residents against the application. They are:-

- Some local residents near the site were not consulted about the proposal
- The density and design mix of the site in not in keeping with the area
- There is no mention of improvements to the access to West End into High Road. A footpath along West End would be a necessity
- There is not enough parking provision
- The untidy state of the site has been contributed by the developer
- A precedent had already been set in the area in previous applications for single storey dwellings only
- No open space has been provided
- Why have the North Level Internal Drainage Board agreed to relax its byelaw limit to 5 metres from the brink of their drain.
- There is no provision for affordable housing

Chairman took no part in the decision making process for the following application

Application No F/YR07/0371 – Formation of an extension to existing wildlife pond – land east of Beechwood Cattle Dyke – no objections

Application Refused

Application No F/YR07/0240/O – erection of 2 dwelling land north west of Fitton Lodge Fitton End. The rights of way officer has confirmed that this site was encroaching onto the bye way

55/07 Addition Item – Streetlights

Letters received from Cambs CC Street lighting. They report that three streetlights have been reported as obsolete and need replacing. They are FPC4 Back Road, FPC15 and FPC16 High Road. The estimated cost for replacing these will be in the region of £1,000 each. It was decided to ask for some confirmation that they will not cost any more than this before going ahead.
