(1) Highway Matters

Clerk has not been able to get any information back from the Highways officer for the area. Cambs County Councillor to be asked to help with ongoing projects.

Unfortunately another accident has taken place along High Road near junction with Hassock Hill. This will be reported to Cambs Highways and asked if they are able to help with this matter.

(2) Speed Watch

Report received from Councillor Mrs Cutler

The hand held device is working well and the sessions held in Gorefield during February and March showed a high percentage speeding. Cambridgeshire Constabulary Speed Watch co-ordinator attended sessions with me and logged Gorefield as an area of concern for enforcement. As our group is only just back in action I am not certain how many enforcement sessions were carried out in my absence. Two CSW sessions have been scheduled to take place in June. If the percentage recorded speeding is still high then I will call on the Constabulary for further enforcement. We are in need of residents living in Gorefield to join the team. Any advertising you can do would be appreciated. At the moment the teams of four are being made up from Murrow and Parson Drove volunteers. Although they are willing to cover Gorefield in addition to doing sessions in their own villages each month it would be good to share the load.

(3) Play Equipment

Councillor Turner has new part for climbing frame and will install after the meeting.

(4) Flag of the Fens

The endorsement of this was discussed and a vote was taken there were 2 for and 4 against therefore it was agreed not to endorse the use of the flag

(6) Report from Allotment Inspection and Review of Rents
