#### Commonwealth War Graves

Councillor Thatcher has met with the CEGC maintenance man who is looking after two war graves in the church cemetery. He will be puting an A4 sign on the gate. There is also a grave in the chapel cemetery which he is also looking after. Councillor Thatcher is concerned about access to the chapel cemetery as it is privately owned. Chairman will make enquires with Wisbech Society as to how they went about obtaining the Wisbech cemetery on North End. A copy of the land registry for the site will be obtained.

#### 76/25 MATTERS ARISING ON THE AGENDA

#### (1) Highway Matters

Work should start on the drainage issues on Gote Lane shortly. Work on Clough Bridge has been re-scheduled for September. Fen Dyke Lane bridge has been reported to Cambs Highways for the removal of the Ivy. Unfortunately nothing can be done about the hedge on Back Road corner as the Land Registry document shows that the grass verge is under the ownership of the property. More work is to be carried out at the cross roads at Bellamy's Bridge. Gorefield Road is in a very poor state Councillor Osborn will ask for some to be done on it.

## (2) Speed Watch

Report received from Councillor Mrs Cutler:

We have sessions scheduled for Gorefield this month. Sadly, August will be the last sessions that our volunteer Peter Thatcher, resident of Gorefield does with us because he has decided to retire. I would like to thank Peter for all the support he has given to CSW and he will be missed. I am at a loss to know how we attract volunteers in Gorefield. We have the scheme in place! Murrow and Parson Drove volunteers have agreed to cover sessions in Gorefield for a while longer but we are desperate for Gorefield residents to step up. On 26th September CSW will attend the Golden Age Fayre at Wisbech St Mary. As this event usually attracts residents from a wide area hopefully there will be some Gorefield residents attend that we are able to recruit. Diane Cutler – Scheme Co-ordinator FDC Report: After I contacted people regarding the proposed FDC Safety Partnership Community Engagements the team would like to take place, Cllr Sam Clark who runs the coffee mornings at Gorefield Community Hall has liaised directly with the FDC team and offered dates for them to arrange an event. When I know the agreed date, if available I will attend to try and recruit CSW volunteers.

Whether this will be tabled before the November submission date remains to be seen.
